

## **Prospectus**

The following is a prospectus for all upcoming 2010 juried shows presented by  
**The Myers Gallery at Muddy's Studio, Santa Ana, California 92705**

### **ELEGIBILITY**

Artists must be at least 18 years of age and reside in the United States.

### **ENTRIES**

Entry fee is \$30 for up to three works per artist, with a maximum of two images per piece. Works must have been completed within the last two years. Work must reflect the theme of the show. Make checks payable to Muddy's Studio. Submit entry fee and form with your CD of images. Entries must be postmarked by listed date. Include a self-addressed, stamped envelope for notification of acceptance or decline. Include packaging with adequate postage for the return of your CD if you want it returned to you.

### **DIGITAL IMAGES ONLY**

Two images per entry are allowed. Images should be in JPEG format, 1200 pixels at the longest dimension, and 300 dpi. All files should be labeled with applicant's first initial and last name followed by image number.

### **INSTALLATION**

All artwork must be installation ready and not to exceed 15" wide by 30" tall. Muddy's Studio reserves the right to reject any artwork due to inadequate preparation for installation or for security or public safety concerns. Work that differs from the images submitted will not be accepted. After installation, no artwork may be removed from the exhibition until the close of the show.

### **SHIPPING**

Accepted artwork must be received by Muddy's Studio by listed dates. The cost of shipping to and from the gallery is the responsibility of the artist. Muddy's Studio is not responsible for any damage during shipment. Works will be insured for 50% of the stated value while in the possession of Muddy's Studio. It is the artist's responsibility to insure their art during the shipping process.

### **SALES**

Muddy's Studio holds a 40% commission on any sold artwork. Artwork not for sale must be marked NFS (not for sale) but have a stated value for insurance purposes.

### **RIGHT TO REPRODUCE**

Muddy's Studio reserves the right to photograph exhibited work and use either these photographs or the artist slides for reproduction in both printed and electronic materials for publicity.
